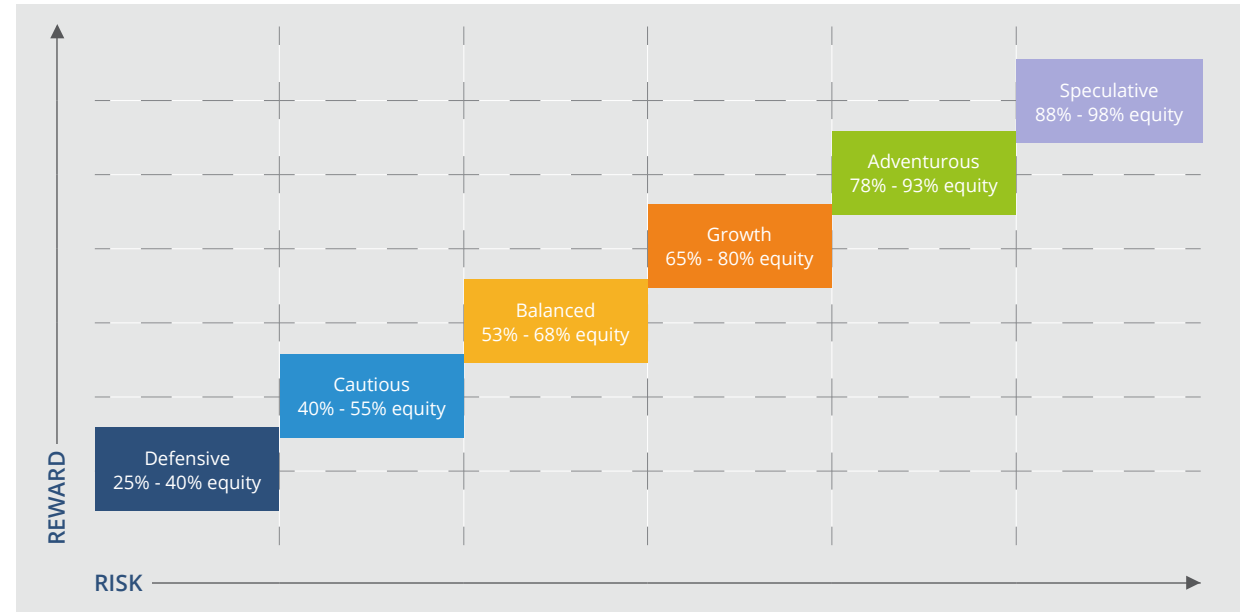

- Funds selected to be held in the portfolio have undergone Square Mile's rigorous research process.
- All funds will hold a 'Recommended' or 'Responsible Recommended' rating, which is awarded to those funds which meet the highest standards in their fields.
- Typically, the portfolio will contain circa 10 funds.
- These are cost constrained portfolios, with an OCF, including the Square Mile fee (15bps) of 0.25%.
- Square Mile branded and managed to Square Mile mandates meaning that from a Consumer Duty perspective you would be considered a Distributor of these products.

The Square Mile Passive Portfolios are available on a wide range of platforms.

The Portfolios

Defensive

Investment objective:

Square Mile aims to manage the portfolio to a volatility range of between 5.9% and 7.5% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 25% and 40%.

Cautious

Investment objective:

Square Mile aims to manage the portfolio to a volatility range of between 7.5% and 9.1% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 40% and 55%.

Balanced

Investment objective:

Square Mile aims to manage the portfolio to a volatility range of between 9.1% and 10.7% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 53% and 68%.

Growth

Investment objective:

Square Mile aims to manage the portfolio to a volatility range of between 10.7% and 12.3% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 65% and 80%.

Adventurous

Investment objective:

Square Mile aims to manage the portfolio to a volatility range of between 12.3% and 13.9% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 78% and 93%.

Speculative

Investment objective:

Square Mile aims to manage the portfolio to a volatility greater than 13.9% over rolling 10 year time periods.

Risk level: Primarily defined by the equity exposure which will range between 88% and 98%.

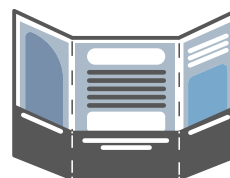

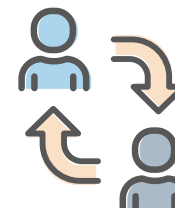
