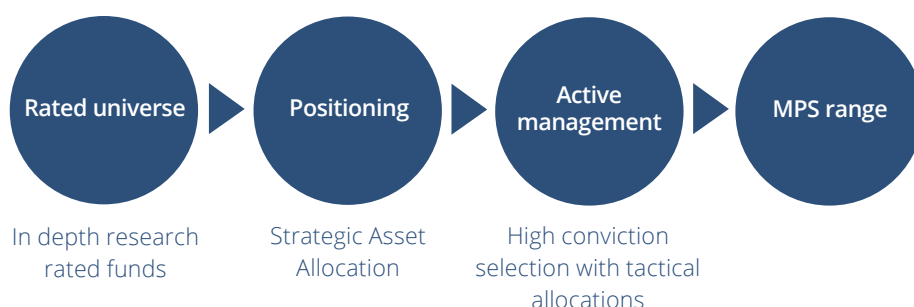

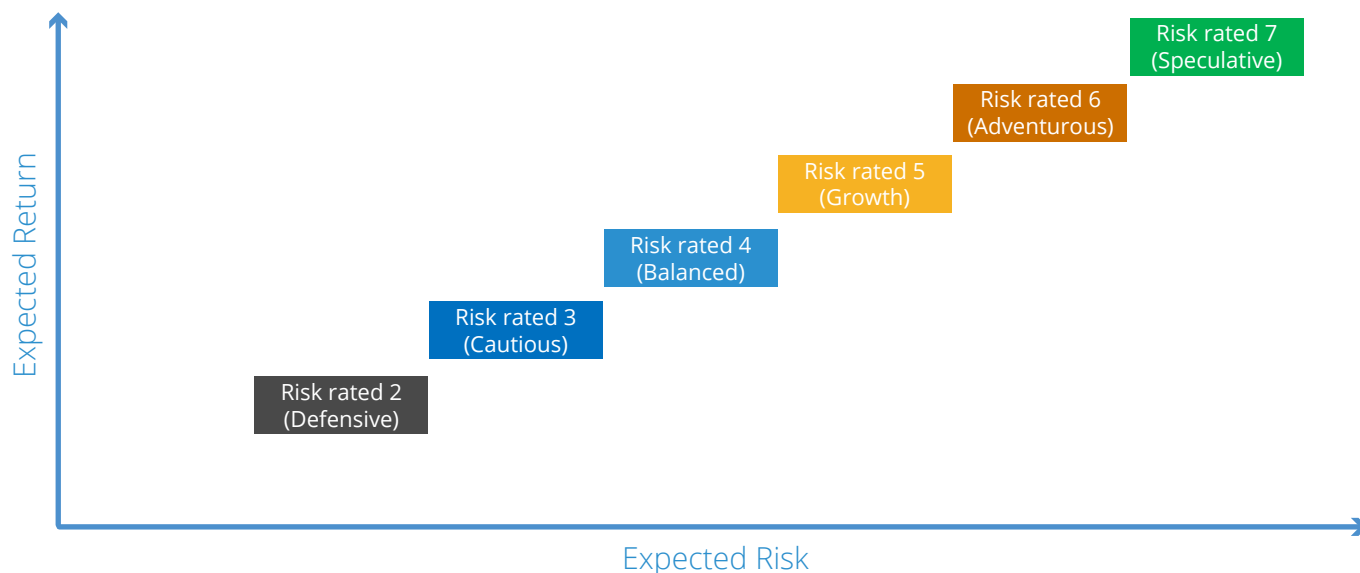

Depending on your clients' needs, our range offers six portfolios designed for varying degrees of risk appetite - from a lower, defensive risk profile, to a speculative one.

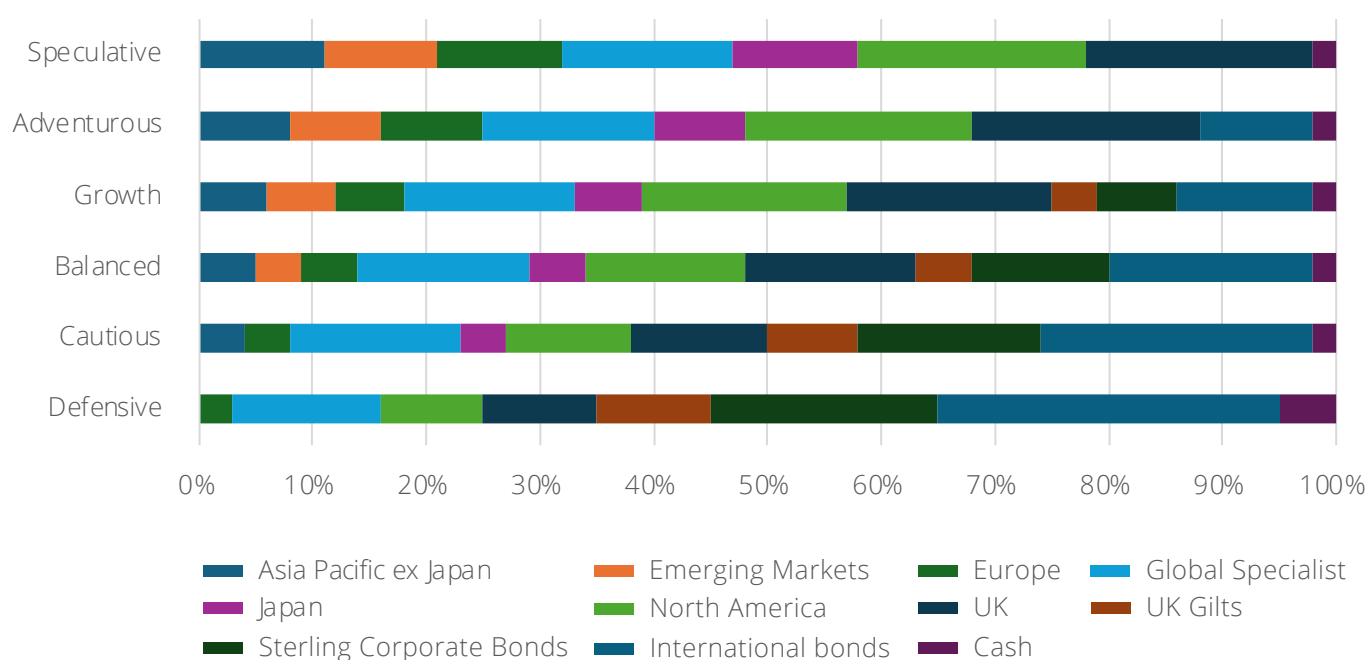

Our scale and size allow us access to a variety of low-cost share classes to deliver better value for your clients. The range offers competitive fees with the ongoing charges figure (OCF) ranging between 0.09% to 0.10%, and the management fee is kept to a minimum at 0.15%.

Each portfolio is managed within a volatility range, over a rolling 10-year period with the aim of delivering consistent returns. This range is not guaranteed and may fluctuate outside of these boundaries.
